## For ILWU-PMA Savings (401(K)) Plan

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for ILWU-PMA Savings (401(K)) Plan, Employer Identification Number 94-1126322, Plan No. 002 for the period July 01, 2023 through June 30, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your Plan is a Multiemployer defined contribution plan, which include the following characteristic(s) of 401(k), Default Investment Account, ERISA Section 404(c), Participant-Directed, Profit-Sharing.

## **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$217,293,810. These expenses included \$404,839 in administrative expenses and \$216,877,297 in benefits paid to participants and beneficiaries and \$11,674 in other expenses. A total of 19026 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$3,143,903,347, as of June 30, 2024 compared to \$2,749,834,869 as of July 01, 2023. During the plan year, the plan experienced an increase in its net assets of \$394,068,478. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$611,362,288, including employer contributions of \$32,119,170, employee contributions of \$143,667,446, other contributions of \$2,312,698, gains of \$114,341,105, from the sale of assets, and earnings from investments of \$318,921,869.
